# **Monitor National Marine Sanctuary Advisory Council Meeting Agenda**

Virtual Meeting July 17, 2024

Time: 6:00 p.m. Meeting time

#### **Welcome and Introductions**

- Paul "Sammy" Orlando called the meeting to order by introducing himself and thanking everyone for volunteering for this term. He welcomed the new and returning council and government members of Monitor National Marine Sanctuary (MNMS).
- Sammy verified that everyone had a list of the member seats and government representatives and began introductions.
  - o MNMS office will offer links to webinars that give further information about the history of the sanctuary and the work that is currently being done.
  - o Sammy went over the agenda for the evening and explained that there will be opportunities to meet with the staff to discuss officer elections and to answer any questions after this meeting.
- Introductions began with the community members present.
  - o Ken "KP" Scott shared that he and his wife own a charter boat company in Cape Hatteras and they drive by the Monitor wreck often. "The sanctuary is my front yard," stated KP.
  - o Carol Price is the conservation director for North Carolina aquariums. She stated that Tane and sharks got her involved. Specifically, her work in community science programs studying sand tiger sharks and characterizing images found in the area around Monitor. She stated that being able to combine the historical with the biological is a great opportunity.
  - o Nathan Richards works for East Carolina University and has been able to work with NOAA staff and learn about the sanctuary system.
  - o Alexis Kimotho is a military spouse and her family is stationed in Hampton Roads. She proclaims to be a Military family enthusiast and has brought her kids up in that realm of thinking too. She hopes to burst the bubble in the military community to help them embrace their new spaces.
  - o Dan Baxter works for the city of Newport News and is retired Navy. He has a background in environmental geology and land management and has worked closely with The Mariners' Museum and Park. He is thrilled to be involved especially because of his wife's enthusiasm for history.
  - o Charles "Bucky" Oliver noticed a lack of awareness for the sanctuary and what is still there and felt he was in a good position to facilitate buzz in the area [around North Carolina] and help promote the work the sanctuary is doing.
  - o Tom McCulloch is a former maritime archaeologist and has worked with NOAA and on plans for National Marine Sanctuaries. Tom currently volunteers at the fishing village where he lives in Florida and hopes to contribute where he can.
- Sammy transitioned the introductions to those present and representing government

seats.

- o Brendan Burke with Virginia department of historic resources was introduced and Sammy also indicated that Brendan also often works at Monitor's sister sanctuary, Mallows Bay-Potomac River.
- o Chris Southerly is with the North Carolina department of natural and cultural resources.
- o Bradley (Brad) Kruger represents Naval History and Heritage Command with the underwater archaeology branch.
- o Will Hoffman is the director of conservation and lead conservator at The Mariners' Museum and Park (TMMP). The more we work with the artifacts the more we learn about the people who were a part of the Monitor's story and the unique opportunity we have to see past, present and future.
- Sammy asked that the Monitor and Mallows Bay-Potomac River staff introduce themselves as well. Tane Casserley, Jessie Frayser, Dana Sanchez, Megan McCabe, Adam Wright, and David Dodsworth were in attendance as well as Mallows Bay's intern Taylor Schneider.

#### Sanctuary Orientation and a Look Ahead

- Sammy shared a presentation (See Appendix A) that began with a map marking Monitor NMS, TMMP, and Mallows Bay-Potomac River National Marine Sanctuary (MPNMS).
  - o He described many partners that either interact with or have content related to MNMS.
- Sammy described the four pillars that guide the work and resources for MNMS and explained their significance as the main themes from MNMS's management plan. Much of what the whole team will do for the remainder of the year will be in preparation for the 50<sup>th</sup> anniversary of the designation.
- Sammy listed the 5 action items and expressed why these items are important such as a sense of pride, stewardship and community benefits.
  - o Sammy hoped that as he began to describe the four pillars, the council would latch onto one that gets them excited and begin thinking of ways the sanctuary can get involved and support things they are already doing.
  - o The first pillar describes historic legacy. Between virtual models, scans and prints and outreach events, our sanctuary hopes to continue to tell the story of *Monitor* and put history in people's hands.
  - o The second pillar is artifact conservation and over the last generation, TMMP has been a world leader in the artifact conservation effort to roll out several pieces that are nearing completion.
  - o Ecology is the third pillar even though the sanctuary does not manage the resources, but others are able to study the living reef that is taking over the site there. Sammy explained the resources that have come about through exhibits, programs and Virtual reality.
  - o The final pillar is about service to the community and an ability to participate in community events, co-branding tourism partnerships and an opportunity to connect with the public.
- In looking forward to the 50<sup>th</sup> anniversary, all of these things can be used to create an event that follows TMMP model of Sips and Trips. There is great potential to bring all of these pillars together. Sammy asked for anyone to share their thoughts about what they

heard.

- o Dan said one word, "wow!" Sharing all of these things with the public is going to be awesome and he looks forward to working with the team.
- o Carol admitted that her perspective is different due to her line of work. She believes one of the hardest things is to bring the ocean to the people because most won't ever get to see it so creating things that can do that is amazing.
- o Nathan agreed that this site is so well known and the way that the sanctuary team and the council is able to bring this site to the people is incredible.
- o Will emphasized that the story of *Monitor* is about bringing people together and read a wonderful quote that emphasized that point.

### SAC Business: Role of Advisory Council and Overview of Officers

- Sammy displayed the list of the community voting seats and indicated that there are several vacancies. (See Appendix B) The government, non-voting seats were also displayed and the difference between the two types of seats was explained.
  - o Community members apply and have set terms to meet the mission of the sanctuary management plan.
  - o The government members are appointed and their terms can vary. The other difference is that consultation must be had in their agency before decisions can be made.
- Sammy gave a brief overview of the charter and its purpose, as well as the role of the Advisory Council Coordinator.
- As a member, Sammy indicated that as a council member, their primary role is to serve as a liaison to the community. The hope is that members and alternates are both equally active in the council and communicate together, especially when it comes to voting.
  - o Sammy challenged the members to go beyond minimum duties listed in the handbook and participate in not only the meetings but in community events as well. He hopes they will also recommend things the sanctuary can be involved in.
- The role of the chair and vice chair was described. Sammy explained these as active roles, not passive. He gave the example of how the Mallows Bay SAC chairs perform those roles and examples of things the chairs plan and lead.
- Sammy asked if anyone is thinking about applying for the chair or the vice chair positions?
  - o Dan Baxter indicated that he is interested in the role.
  - o Sammy offered to set up time with not only our team but also with the Mallows Bay chair and vice chair.
- Sammy asked for considerations for in-person meetings: location, meeting duration, if
  weekdays or weekends are preferred etc. There will also be a survey sent out to share
  your thoughts.
  - o Bucky shared about the value of being in person but the hybrid approach is probably the most feasible given the members are across two states.
  - o Nathan agreed that sometimes it is difficult to predict what will happen so a hybrid option would be helpful. He did indicate that this time of the day is doable and alleviates work related issues.
  - o Carol acknowledged that it is not too far to travel and she is willing to do that with advanced notice.
  - o Dan agreed that being in person allows you to shake people's hand and see

their faces to determine how they feel about things.

- o Will recommended that there is at least one in-person meeting a year and possibly the others could be hybrid? That would give others enough advance notice if they know there is a specific time of year for an in-person meeting.
- Sammy acknowledged the events on the agenda, specifically the October 23<sup>rd</sup> virtual meeting and other community events taking place. He pointed out the 50<sup>th</sup> anniversary event on February 1<sup>st</sup> and would like to see as many members in person for that event as possible.

#### **Public Comment**

• There were no members of the public present on the call.

#### Closing Remarks / Adjourn

- Sammy reminded that there would be webinars sent out to learn more about the history of the sanctuary and the work that is taking place. Also let Jessie know if you would like to learn more about the chair and vice chair.
- Nathan shared an event with the <u>NC Maritime History Council</u> that will take place November 7-10th.
- Sammy adjourned the meeting.

## Advisory Council Charter

- Instrument by which the council was established
- Scope of the council's responsibilities
- Constitution for the council's operation (elections, meetings)

MONITOR NATIONAL MARINE SANCTUARY ADVISORY COUNCIL CHARTER

Establishment and Authority Pursuant to the National Marine Sanctuaries Act § 315,1 the Secretary of Commerce, through the director of the Office of National Marine Sanctuaries (director), hereby renews Monitor National Marine Sanctuary Advisory Council (advisory council). The advisory council is governed by the act and shall operate pursuant to the terms of this charter and the National Marine Sanctuary Advisory Council Implementation Handbook (handbook).

# Sanctuary Advisory Council Coordinator

- Provides direct support to Sanctuary Superintendent, SAC Chair and SAC Working Groups
- Organizes council meetings including logistics, communication and agendas
- Ensures compliance of meeting operations, e.g., meeting protocols, SAC charter and member updates, meeting notes and information distribution
- Assists all advisory council members and alternates with questions or comments related to the council



### **Council Member Roles**

- Provide advice to NOAA on management, use, and protection of the sanctuary
- Serve as a liaison between NOAA and communities and constituents
- Identify potential partners and constituent groups for collaboration
- Help identify and resolve issues involving the sanctuary
- Review and provide input on sanctuary plans
- Assist in developing informed constituency
- Provide technical expertise and supporting information

## Primary and Alternate Members

- Interchangeable Input and participation from both are valued and encouraged!
- Allows for added expertise, representation and diversity
- If a primary is unable to attend a meeting, the alternate should attend
- Alternate votes only in the absence of the member
- Get to know each other!

# Beyond the Charter

- Actively participate in quarterly meetings in person and virtual
- Attend Sanctuary events and community programs
- Create synergies that advance the four pillars mutual benefit
- Leverage funding and resource opportunities

## Chair and Vice-Chair

Chair: Works with NOAA to set agenda, presides over meetings,
 signs correspondence, represents council's interest to the public

 Vice-Chair: Serves in absence of chair, assists in performing executive duties of the council

  - National SAC requirements
  - Capitol Hill requirements
  - Sanctuary as gateway to partners & communities
